PSWCT/UP Behavioral Health and Resilience in the Workplace: Management of Psychological Elements Associated with Workplace Injuries

We will address common workplace communication challenges in this context as well as the way that burnout, compassion fatigue and moral injury play a role in behavioral health, and simple, accessible resilience building strategies.

PSWCT/UP School Safety Walk-Through

Thursday, February 15, 2024 10:00 am – noon

The ultimate goal in School Environmental Health & Safety is to shift in how safety is defined and practiced by all school partners: Safety is not the absence of accidents, incidents or claims, but the existence of a system and structure that supports awareness, personal responsibility, collaboration, mutual care and belonging. In a strong community, everyone should be aware of safety risks and have a commitment to address them.

School leaders can improve school safety and help reduce the risks to staff and students by guiding and training district staff to always look through their "safety glasses." Periodically conducting safety walk-throughs of buildings and grounds, and reporting and correcting hazardous exposures can prevent health and financial loss.

To support these efforts, PSWCT/ UP has partnered with Northeast Washington Educational Service District 101 to offer an overview of the Safety Walk-Through Basics, provide recommendations, and present the resources and checklists developed for membership use. This training is designed for everyone working in schools and not just the designated Risk or Safety Managers.

PSWCT/UP Reasonable Assurance: Refresher & Updates

This training is specifically targeted to school district staff who are responsible for unemployment compensation, such as those within human resources or payroll departments. Educational employees are not eligible for unemployment benefits during traditional break periods in situations where they have "reasonable assurance" that they will continue working after the break. Reasonable Assurance allows districts to hire guest employees to work during the school calendar, but not be financially responsible for compensation during breaks.

PSWCT/UP - Washington State Department of Health K-12 School Health & Safety Guide Updates

The Health and Safety Guide for K-12 Schools in Washington was generated in response to WAC 246-366-140, "Primary and Secondary School Regulations," that directed the Washington State Department of Health (DOH) and the Office of Superintendent of Public Instruction (OSPI) to generate a Guide to help prevent and reduce injuries and illnesses in Washington's K–12 schools.

The result of this collaboration is the edition released in 2000 and the subsequent updated version in 2003. In 2023 a committee of school and health personnel assembled to incorporate users' comments, add new elements and best practices, and to update code references.

The update effort was led by our speaker, Nancy Bernard, Manager of the Washington State DOH Indoor Air Quality and School Environmental Health and Safety Programs. Nancy will offer an overview of the Guide with special emphasis on additions and modifications. Now the Guide can return to its well-deserved spot of being the ultimate resource and reference for our school Environmental Health & Safety (EH&S) work.
